Course Description:

This Medication Management course can help direct care workers prevent medication errors. Preventing medication errors promotes patient safety. This program will teach standards to administer medications safely, avoiding risky behaviors and special handling of narcotic medications. The student will explain and demonstrate the appropriate State of Nevada procedures for medication administration.

Course Objectives:

After Completing this Course, the Student:

1. Understand the regulations governing “Scope of Practice” in the Residential communities as covered by NAC and NRS 449 for Med Techs.
2. Explain how continual observation of each resident for potential adverse reactions to medications and/or signs/symptoms will promote safety and quality care.
3. Understand and articulate the importance of client rights, infection control, and communication with the healthcare team.
4. Identify and demonstrate the proper managing of medications and assisting the residents to self-administer medications.
5. Identify the importance of assuring that the medications coincide with what the authorized prescriber (e.g., physician) has prescribed.
6. Explain the ordering and refilling medications procedures
7. Demonstrate logging medications on community-approved medication log when received and proper documentation for all medications administered.
8. Demonstrate destroying medications in accordance with state procedures. Identify how storing medications safely can reduce medication errors.

Course Requirements:

1. **Maintain a three-ringed binder that will contain the course syllabus, class notes, handout, returned papers and all other related materials.**
2. **There will be no excused absences; student must re-schedule class if he cannot attend class.**
3. **Students must complete all reading and written assignments as/when instructed.**
4. **Students must wear scrubs and closed-toed shoes with no heel.**
